Context and Environment

Background

This Terms of Reference outlines the requirements for hiring up to three consultants who will use artificial intelligence tools to design comprehensive learning materials for the English language curriculum of the city of Barranquilla. Each level comprises four instructional units, with each unit structured for an eight-week teaching period, plus one week dedicated to assessment and another to a project-based learning component. The curriculum follows a student-centred approach that promotes communicative, project-based learning.

The curriculum design initiative is part of an international cooperation agreement between the British Council and the city of Barranquilla, aimed at implementing the city's bilingualism public policy: Barranquilla Bilingüe. This policy seeks to strengthen the teaching and learning of English through the development of high-quality, standardized educational programs aligned with the 2020 update of the CEFR, and by integrating local sociocultural elements that make language learning relevant and inclusive.

The curriculum design process began in 2024 and has produced level-based syllabi for Levels 2 through 10, along with Schemes of Work (mallas curriculares) and a set of suggested sample lessons. The next phase focuses on developing complete sets of pedagogical materials that will complement the curriculum and support its effective implementation in the classroom.

The selected consultant will play a key role in producing engaging and pedagogically sound learning resources that bring the existing curriculum to life. The development and production of these materials should be supported by Artificial Intelligence (AI) tools and technologies to ensure efficiency, innovation, and high-quality outcomes.

Purpose

To contract up to three experienced ELT Materials Designers/Developers to create comprehensive, high-quality, engaging, and pedagogically sound learning materials spanning all levels of the English language curriculum for Barranquilla. The consultants will use Al-assisted design tools to enhance efficiency and innovation throughout the full development process, ensuring alignment with the materials section of the curriculum Schemes of Work.

Scope of Work

The consultants engaged in designing and producing materials for the Barranquilla English Language Curriculum will be responsible for delivering a comprehensive and diverse set of pedagogical resources aligned with the established curriculum framework.

The curriculum consists of 10 levels, ranging from Level 2 to Level 11, each corresponding to a school grade. Each level comprises 4 units, with each unit spanning 10 weeks of instruction. Based on an analysis of sample units representing three distinct educational groups, **the estimated** volume of materials to be produced is as follows:

- Primary levels (Level 2 to Level 5): approximately 400 materials.

- Lower secondary levels (Level 6 to Level 8): approximately 300 materials
- Upper secondary levels (Level 9 to Level 11): approximately 300 materials

This results in a total estimated production of around 1,000 distinct materials, encompassing flashcards, worksheets, audios, videos, role-play and scenario cards, graphic organisers, checklists, quizzes, project materials, conversation transcripts, reflection templates, among other teaching, learning, and assessment materials.

It is important to note that not all materials are required to be produced by the consultants. In some instances, videos and other resources indicated in the curriculum may be used directly for educational purposes without modification. Consultants should exercise discernment in selecting and integrating such existing materials where appropriate, focusing their production efforts on developing original and customised content that aligns with the indicative curriculum materials.

Content Requirements

- All materials must be age-appropriate and suitable for the designated student levels (primary, lower secondary, and upper secondary).
- Content must be culturally relevant, reflecting the context and identity of Barranquilla and Colombia.
- Language use shall align accurately with the corresponding CEFR levels designated for each curriculum stage.
- Materials should facilitate differentiated instruction to accommodate diverse learner needs where applicable.
- Depending on the level of complexity, difficulty, or production limitations, equivalent materials may be produced, subject to prior agreement with the British Council.

Quality Standards

- Materials must feature design and layout tailored to the specific age group and level.
- Content must be free from errors, including spelling, grammar, and factual inaccuracies.
- A consistent visual identity should be maintained within each level, while ensuring clear differentiation between levels.
- Accessibility must be carefully considered in all materials, including appropriate font size, colour contrast, and clear layouts to support all learners.
- All Al-generated content must be verified for copyright compliance, ensuring lawful use for commercial and educational purposes.
- Audio materials must feature clear, natural-sounding, age-appropriate voices—whether human-recorded or Al-generated.



Activities

Each consultant will be responsible for the following activities throughout the contract period:

- A1. Participate in orientation and kick-off meetings to understand the curriculum framework, design principles, Syllabi, Schemes of Work, and local education context including Barranquilla's culture and geography, if applicable.
- A2. Develop and maintain a comprehensive work plan and timeline for all materials production, including identification and documentation of AI tools to be used.
- A3. Use approved AI tools and platforms to support ideation, drafting, adaptation, visual design, audio production, translation, and formatting of materials, ensuring all outputs meet quality, ethical, and copyright standards.
- A4. Develop and/or produce the variety of materials appointed by the curriculum schemes of work such as flashcards, worksheets, audios, videos, role-play and scenario cards, graphic organisers, checklists, quizzes, project materials, conversation transcripts, reflection templates, among other teaching, learning, and assessment materials and supplementary resources aligned with curriculum objectives and CEFR levels.
- A5. Produce a sample set of materials for each material type for approval, and incorporate feedback received from the British Council to refine both content and design.
- A6. Ensure all materials are culturally relevant, age-appropriate, accessible, and maintain consistent visual identity and branding throughout all levels.
- A7. Conduct quality assurance including fact-checking, proofreading, functional testing of audio, video and digital elements, and maintain detailed documentation of all AI tool usage and content development processes.
- A8. Participate in regular coordination meetings and peer review sessions to facilitate collaboration, receive feedback, and maintain coherence across all materials and levels.
- A9. Incorporate stakeholder feedback and submit final deliverables including all materials and AI documentation within agreed timelines.
- A10. Understand and adhere to all relevant British Council policies and codes of conduct, including those on data protection, safeguarding, confidentiality, and ethics. Reference materials are available in the British Council Policies for Consultants.
